Item No. 1:- Admission to 3-year Integrated Ph. D programme of JRF/NET/SET candidates in view of circular dated Feb 7, 2018, issued by Assistant Registrar, Research.

After the issuance of above referenced circular by Assistant Registrar, Research, the department has so far received 12 applications of JRF/NET/SET candidates for admission to integrated Ph. D programme. Out of 12 candidates 7 candidates have qualified JRF/NET/SET exam in Nov 2017, 1 (one) in May 2017, 2 (two) in July 2016, 1(One) in April, 2016 and 1 (one) in April, 2014. As per the circular applicants were required to apply within one month from the declaration of JRF/NET/SET results. However, in this case it was not possible as the circular has been issued almost 3 months after the declaration of JRF/NET result.

Resolved that, since it is for the first time that such procedure is adopted for Ph. D admission, so one time relaxation in terms of time period may be granted and these candidates may be admitted to integrated Ph. D course. However, the case may be forwarded to Dean Research through Dean, SOBS for necessary approval.



Item No. 4:- Ph. D Synopsis of scholars Fiza Fayaz and Aiman Fayaz







Resolved that MS. Shazia Bashir be considered as part time scholar if otherwise eligible.



It was resolved that supervisors will be allotted to the scholars very soon.


