
Consequent upon the above all the concerned teachers shall be required to submit six monthly progress reports to the office of the Dean Research. The first report should indicate the type of activity under taken along with the evidence of research proposal submission to external funding agencies. The second and final progress report should highlight the achievements along with the data generated if any, are pre-print/re-print/letter of acceptance of a publication, with due acknowledgement of the university support.

The grants shall be utilized toward purchase of personal Computer, Printer, Stationary Items, small Consumable /Chemicals etc. Subject to observance of terms and conditions of the University.

Each teacher shall be required to submit Utilization Certificate and statement of expenditure on prescribed format duly signed by the chartered accountant of the university.
